There will be 4 games played in each trial. You may play in all 4 games in any level(s) you are eligible for. There are no prerequisites for Level 1 – (you do not “need” Nursery title to enter Level 1 but it is great practice. Nursery and Level 1 can be played in the same trial. ***Move ups are permitted with prior notice and payment to the trial secretary before the game or level begins.***

Games and Levels being offered:

Trail Bound (previously called Lost Hiker) - Nursery, Level 1, Level 2 – quarry based game (rats)

Break Out - Nursery, Level 1, Level 2 – obstacle based

Lock & Key and Puzzled - Nursery, Level 1, Level 2 (Scent-Birch) – scent based (Birch)

Trial Schedule:

The site will open at 8:00 AM. The initial briefing * will commence at 8:30 AM, followed by the first dog on the line at 9:00 AM.

**will include a detailed introduction to games as needed for all new teams!*

Trial Rules/Info:

1. All breeds are eligible to compete. Dogs must be registered with WCERA. There is a one \$25 fee to register dog; details available at WCERA.dog
2. Crating will be in your car. Please come prepared with everything to keep you and your dog(s) comfortable – water, food, snacks, etc.
3. Please respect the property. Park where directed and use designated potty areas. Be sure to clean up after your dog. BIS are allowed with panties and must potty in separate assigned area. Please notify trial secretary ASAP if you have a BIS. Porta potty on site for humans.
4. Run order will be posted, however if someone is not ready, then we will move on to the next dog to keep the trial flowing. There will be a staging area where you can stand with your dog as it gets close to your turn.
5. Qualifying runs will receive a flat ribbon. New Nursery titles will be double flats. New Level 1 titles and above will receive rosettes. For Level 1 and above in games with 4+ dogs competing, dogs will also receive flat ribbons for first place (blue), second place (red), and third place (yellow).
6. All rules must be followed according to WCERA Game Master Rule Book. This can be found at WCERA.dog
7. Minors are not allowed to compete at this event (WCERA has a junior handler program in progress).
8. Refunds will be given until closing date or with a written note from a veterinarian.
9. In “rooms” that are secure, dogs may run on or off leash. This will be verified at briefing on the day of trial. Dogs must always remain under control. Dogs may be leashed at any point.
10. **Maximum of ONE reset per game/per level for handlers with multiple dogs.**

12. Entries will be confirmed by email. If mailing in form, be sure to write clearly.
