Refunds will be given for injured or deceased dogs with written notification to the test Chair with an accompanying note from a veterinarian. Participants exhibiting COVID symptoms should contact the Trial Chair. Any refunds will be credited 7 days after the event.

Participant Information

- No concessions are provided at the event. No water or snacks will be provided.
- This event is outdoors on private property.
