RELEASE AND WAIVER OF LIABILITY

In consideration of the acceptance of this entry and in return for my being allowed to participate in this event with the opportunity to win prizes, ribbons, and/or trophies, I hereby **RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE** the Barn Hunt Association, LLC, ("BHC"), Hat Trick Caos, LLC ("HTC"), its members, directors, governors, officers, agents, event secretary and chair, other event officials and the owner(s) or lessor of the premises and any provider of services that is necessary to hold this event and any employees or volunteers of the aforementioned parties and any BHC approved judge or presenter, presenting or judging at this event ("RELEASEES"), from any and all liability of any nature including, but not limited to, any claim, and/or cause of action arising out of or related to any loss or damage, theft, disappearance, or injury, including death that may be sustained by me or my dog arising out of participation in this event or that occurs as a result of my traveling to and from this event. I agree to **INDEMNIFY AND HOLD HARMLESS** the RELEASEES from any and all liability of any nature, including, but not limited to, loss, liability, damage or costs, including court costs and attorneys' fees, that RELEASEES may incur due to my participation in this event and my traveling to and from this event, arising out of injury, death, theft, disappearance, loss or damage or other that is caused or alleged to be caused by my dog, other dogs, my negligence, the negligence of the RELEASEES, or by the negligence of any other persons.
