### Refund Policy

No refund for a dog that is absent or withdraws after closing. No refund for a dog that is disqualified, excused or barred from competition by the Trial Committee. Refunds will be given for injured or deceased dogs with written notification to the test Chair with an accompanying note from a veterinarian. Participants exhibiting COVID symptoms should contact the Trial Chair. Any refunds will be credited 7 days after the event.

### Participant Information

- Smoking is NOT ALLOWED unless you are in your vehicle.
- No concessions are provided at the event. **No water or snacks will be provided.**
- This event is outdoors on private property.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms
- It is expressly understood the exhibitors alone are responsible for the behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such a case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please pick up after your dog and put bags in red buckets.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be payable to **Hat Trick Caos**.
- Hat Trick Caos reserves the right to refuse any entry without cause or explanation.
- Please keep dogs away from livestock
