Entry fees & Limits

Pre-Entry: Instinct \$15 Novice, Open \$20, Senior, Master, Crazy 8's \$25 (if done on secreteerrier)

ADD \$5 for Late Entries. Late entries are not guaranteed entry to trial and will be accepted only up to Judging Limits. Confirmations will not be sent for late entries.

Club is limiting runs for each judge at a MRV (max. run value is weighted according to class) of 150.. The club will limit entries accordingly.

Refund Policy

RELEASE AND WAIVER OF LIABILITY

In consideration of the acceptance of this entry and in return for my being allowed to participate in this event with the opportunity to win prizes, ribbons, and/or trophies, I hereby **RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE**, the Barn Hunt Association, LLC, ("BHA"), Hat Trick Caos, LLC ("HTC") Teamworks dog Training LLC, its members, directors, governors, officers, agents, event secretary and chair, other event officials and the owner(s) or lessor of the premises and any provider of services that is necessary to hold this event and any employees or volunteers of the aforementioned parties and any BHC approved judge or presenter, presenting or judging at this event ("RELEASEES"), from any and all liability of any nature including, but not limited to, any claim, and/or cause of action arising out of or related to any loss or damage, theft, disappearance, or injury, including death that may be sustained by me or my dog arising out of participation in this event or that occurs as a result of my traveling to and from this event.
